- $2. The rate per sq. ft. \ of Basic Sale Price of the unit shall be firm. There would be \ no escalation in the rate of the BSP of unit once unit is booked and payment is realized by the company.$
- 3. All applicable govt. charges, taxes, cesses like EDC, IDC, City Development charges and service tax., VAT, labour cess and other taxes, cesses, lease rent, levies etc at present in future and any other enhancement thereof shall be payable extra by the applicant/allottee on proportionate basis.
